

Selling conditions

1 - All the material offered is guaranteed authentic and without hidden defects, unless otherwise indicated. For the photographed lots, the photo is decisive for what concerns margins, perforation, centering and cancellation. The most important copies and series are signed or accompanied by a photographic guarantee certificate from the most famous philatelic experts.

The numbering refers to the Sassone catalog for Italy and the Italian area. The reference to other catalogs will be specifically indicated.

2 - To allow you a correct examination of the lots, photographs with enlargement of the obverse and reverse and any certificates, are present on the site; the photographs in the catalog are examples and are not decisive for the quality of the lot, those published on the website www.quattrobajocchi.com are valid.

3 - The offers by correspondence will be inserted in the order of arrival on the website and will participate together with those online, the offers will be anonymous to protect the privacy of the offerer, if you want you can follow the progress of your offers online .

For this reason, offers cannot be accepted subject to an increase, or “at best” or similar, the amount written in the order form will follow the predetermined steps in the program with a trend from 5% to 10% maximum; in the event of a tie in the offer, the one made first wins, moreover, cumulative offers for multiple lots cannot be accepted.

Complaints due to negligence or error in compiling written offers or those made on the website will not be accepted.

4 - Telephone and internet offers - We decline any responsibility towards the participants for any inconvenience that may occur during or before the connection.

5 - The Quattrobajocchi Philately reserves the right to withdraw and add lots as well as the right to refuse an offer.

The hammer price will be increased by 22% for each lot awarded, VAT. included and without any other additional charge, any shipping costs are excluded. Example: hammer price € 100 + € 22 surcharge = € 122

Any unsold lots will remain available at the base price + 22% commissions for the 15 days following the auction deadline and you will be able to consult their availability directly online.

6 - Payment must be made upon delivery of the lots and for mail order buyers within 7 days of receipt of the invoice, and can be made as follows:

- Credit card with 3.5% surcharge

If the buyer has not yet paid the balance due after 15 days of receipt, Filatelia Quattrobajocchi reserves, according to its free appreciation, the following rights or legal actions:

a: terminate the sale without further notice to the buyer;

b: proceed with the sale of the aforementioned lots

c: to take any legal way to recover one's credit;

7 - Any payment extensions may be granted on the basis of any agreements that must in any case be formalized before the expiry of the sale.

8 - Once payment has been made, the lots can be shipped by insured, or by other means requested by the purchaser at his own risk and expense, being exempt from any liability by showing the shipping receipt made by the requested means. Unless otherwise specified, shipments will be made by Italian Post by conventional insured.

For large lots, the related costs will be communicated from time to time.

9 - We reserve the right to accept or refuse the request for “extensions”. However, it should be noted that “extensions” are not accepted for lots in the description of which the catalog mentions that they are accompanied by a photographic certificate. It is also specified that any granting of “extensions” does not change the payment terms referred to in point 5.

10 - Any complaints must be made upon delivery of the lots for those who collect at the headquarters, whether they are agents or commission agents. For buyers by post (mail order offers) complaints must be received within 15 days of shipment. Complaints will be taken into consideration only in the event that, in the opinion of two well-known experts, the lot is not original or is substantially different from our description.

11 - It reserves the right to ask participants for information on their personal details and bank references, as well as the right to refuse the offer

12 - By sending their purchase order, the buyer fully accepts all the conditions of sale listed above. The Court of Palermo is competent for any controversy.
